## ELIGIBILITY

Entries are open to amateur golfers who: a) are members in good standing of a PNGA member club; and b) have a USGA Handicap Index or Golf Canada Handicap Factor not exceeding 4.4 at the close of entry.

**There is no pre-qualifying for this Championship.** The field of 168 will be filled by Presidential Invitations and exempt players followed by the lowest USGA Handicap Indexes and Golf Canada Handicap Factors at the close of entry.

A maximum number of 32 Presidential Invitations may be extended to qualified individuals. Individuals seeking a Presidential Invitation must submit a resume to the PNGA office outlining their major accomplishments by June 1, 2019. Presidential Invitations may be granted to both PNGA members and non-PNGA members.

## AGE

No age requirements.

## ENTRIES

Entry applications can be filed online at [www.thepnga.org/championships](http://www.thepnga.org/championships) with a credit card, or by mail with a completed paper application form and check or credit card authorization form. Payment will be processed at the time of entry. A full refund will be issued to entrants who are placed on a waiting list and do not make the starting field.

Entry applications, along with the appropriate fee, must be received by the PNGA by 4:30 p.m. on June 17, 2019. Refunds due to cancellation on or before June 17, 2019 are subject to a \$10 service fee. After June 17, 2019 and up until round one pairings are released, refunds for documented and approved medical reasons are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

Late entry applications may be accepted and used to fill spots if they become available up until a time that the PNGA staff establishes. Late entry applications will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the PNGA in order to submit a late entry application.

## CONDITIONS

The PNGA Champion of Champions Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

## CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and may be subject to disqualification under the PNGA Code of Conduct at any time, from any PNGA Championship. **The PNGA Code of Conduct will be provided to all contestants prior to the Championship.**

## CARTS

The use of automotive carts during the championship will not be permitted. Spectator carts will not be permitted.

## CADDIES

A player may provide his own caddie. Host club caddies will not be available at Tacoma C&GC. Caddies are available at Chambers Bay and can be scheduled by calling the Caddie Department at (253) 552-4869.

## DRESS CODE

The PNGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. The full PNGA Dress Code Policy can be found online at [www.thepnga.org/policies](http://www.thepnga.org/policies) and will be provided to all players, along with any additional measures required by the host club, after the entry deadline. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

## PRACTICE ROUND

All contestants will be allowed one complimentary practice round at Tacoma C&GC prior to the championship and one reduced rate practice round at Chambers Bay. Consideration will be made for out-of-town players with regard to reserved starting times the day prior to the championship. Contestants can reserve practice round times directly through the golf shops. All practice round times are at the discretion of the golf shop staff.

## STROKE LIMIT

Players must return a score within 12 strokes of the course rating in at least one of the rounds. Failure to do so will disqualify the player from future entry into the PNGA Men's Amateur Championship for a minimum of two years.

## CHAMPIONSHIP SCHEDULE

The championship will be conducted in two stages:

**Stroke Play** - All players must complete the 36-hole stroke play qualifying in order to determine the 64 players who will advance to match play. Players will play one 18-hole qualifying round at Tacoma Country & Golf Club and one 18-hole qualifying round at Chambers Bay. In the event of a tie for the final qualifying spot(s), a hole-by-hole playoff will be used to determine the qualifiers. In the event of a tie for the Qualifying Medalist, a hole-by-hole playoff will be used to determine the Medalist. All playoffs will be contested at Tacoma Country & Golf Club.

**Match Play** - The General Numerical Draw will be in effect. Single elimination match play. All matches are 18 holes except for the 36-hole Championship Match. All match play will be contested at Tacoma Country & Golf Club.

**WITHDRAWAL POLICY**

All refunds prior to the entry deadline are subject to a \$10 administrative fee. Refunds are not available after the closing deadline except for documented and approved medical reasons. Refunds approved after the closing deadline, and up until round one pairings are released, are subject to a \$25 administrative fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

During play of the championship, a competitor must notify PNGA staff and state his need to withdraw. Entrants who unofficially withdraw (by not notifying the PNGA staff or without having sufficient reason to withdraw) will not be granted entry into any future PNGA championship for a minimum of two years.

**LODGING**

The PNGA recommends that contestants make their lodging arrangements at the earliest possible date. The PNGA provides highly discounted rates on hotels. Contestants can access hotel deals on the PNGA Men's Amateur Championship web page ([www.thepnga.org](http://www.thepnga.org)).
