**FIELD LIMIT: 60 (SENIOR) | 30 (SUPER SENIOR) | ENTRY FEE: \$180 (U.S. FUNDS)
ENTRY DEADLINE: SEPTEMBER 19, 2019 AT 4:30 P.M.**

ELIGIBILITY

Entries are open to amateur female golfers who are: a) members in good standing of a PPGA member club; b) meet the age requirements; and c) have a USGA Handicap Index or Golf Canada Handicap Factor not exceeding 22.4 for the Senior Championship and 26.4 for the Super Senior Championship at the time of entry.

The field limit of 60 in the Senior Amateur and 30 in the Super Senior Amateur will be filled by exempt players followed by order of entry receipt. Since both Championships are conducted concurrently, the PPGA reserves the right to modify the field limits to reach a full field of 90 players.

AGE

Senior Amateur entrants must be 50 years of age or older by September 30, 2019. Super Senior Amateur entrants must be 65 years of age or older by September 30, 2019.

ENTRIES

Entry applications can be filed online at www.thepnga.org/championships with a credit card, or by mail with a completed paper application form and check or credit card authorization form. Payment will be processed at the time of entry. A full refund will be issued to entrants who are placed on a waiting list and do not make the starting field.

Entry applications, along with the appropriate fee, must be received by the PPGA by 4:30 p.m. on September 19, 2019. Refunds due to cancellation on or before September 19, 2019 are subject to a \$10 service fee. After September 19, 2019 and up until round one pairings are released, refunds for documented and approved medical reasons are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

Late entry applications may be accepted and used to fill spots if they become available up until a time that the PPGA staff establishes. Late entry applications will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the PPGA in order to submit a late entry application.

CONDITIONS

The PPGA Champion of Champions Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and may be subject to disqualification under the PPGA Code of Conduct at any time, from any PPGA Championship. **The PPGA Code of Conduct will be provided to all contestants prior to the Championship.**

CARTS

The use of automotive carts during the championship is permitted. Cart fees are \$40 per rider, includes both rounds, and must be paid during registration. Spectator carts will not be permitted.

CADDIES

A player may provide her own caddie. Host club caddies will not be available.

DRESS CODE

The PPGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. The full PPGA Dress Code Policy can be found online at www.thepnga.org/policies and will be provided to all players, along with any additional measures required by the host club, after the entry deadline. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

PRACTICE ROUND

All contestants will be allowed one complimentary practice round prior to the championship. Consideration will be made for out-of-town players with regard to reserved starting times the day prior to the championship. Contestants can reserve practice round times directly through the golf shop. All practice round times are at the discretion of the golf shop staff.

CHAMPIONSHIP SCHEDULE

36-hole Individual Stroke Play Competition (gross and net), with each Championship playing from a separate set of tees. Players will be flighted based on course handicap. In the event of a tie for the gross championship, the winner will be decided immediately by a hole-by-hole playoff. All other ties will be broken using USGA retrogression.

WITHDRAWAL POLICY

All refunds prior to the entry deadline are subject to a \$10 administrative fee. Refunds are not available after the closing deadline except for documented and approved medical reasons. Refunds approved after the closing deadline, and up until round one pairings are released, are subject to a \$25 administrative fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASSED.**

During play of the championship, a competitor must notify PNGA staff and state her need to withdraw. Entrants who unofficially withdraw (by not notifying the PNGA staff or without having sufficient reason to withdraw) will not be granted entry into any future PNGA championship for a minimum of two years.

LODGING

The PNGA recommends that contestants make their lodging arrangements at the earliest possible date. The PNGA provides highly discounted rates on hotels. Contestants can access hotel deals on the PNGA Senior and Super Senior Women's Amateur Championship web page (www.thepnga.org).
