TEAM FIELD LIMIT: 40 (SENIOR) | 20 (SUPER SENIOR)

TEAM ENTRY FEE: \$440 (U.S. FUNDS)

ENTRY DEADLINE: SEPTEMBER 3, 2019 AT 4:30 P.M.

ELIGIBILITY

Entries are open to amateur female golfers who are: a) members in good standing of a PNGA member club; b) meet the age requirements; c) have a USGA Handicap Index or Golf Canada Handicap Factor not exceeding 40.4 at the time of entry; and d) partners' course handicaps must be within 8 strokes of one another or an adjustment will be made to the higher player's course handicap to meet this requirement. The maximum allowable course handicap will be 36 (players above this will be reduced to meet this requirement).

The field limit of 40 teams in the Senior Team and 20 teams in the Super Senior Team will be filled by exempt teams followed by order of entry receipt. Since both Championships are conducted concurrently, the PNGA reserves the right to modify the field limits to reach a full field of 60 teams.

AGE

Senior Team entrants must both be 50 years of age or older by September 16, 2019. Super Senior Team entrants must both be 65 years of age or older by September 16, 2019.

ENTRIES

Entry applications can be filed online at www.thepnga.org/championships with a credit card, or by mail with a completed paper application form and check or credit card authorization form. Payment will be processed at the time of entry. A full refund will be issued to entrants who are placed on a waiting list and do not make the starting field.

Entry applications, along with the appropriate fee, must be received by the PNGA by 4:30 p.m. on September 3, 2019. Refunds due to cancellation on or before September 4, 2019 are subject to a \$10 service fee. After September 3, 2019 and up until round one pairings are released, refunds for documented and approved medical reasons are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

Late entry applications may be accepted and used to fill spots if they become available up until a time that the PNGA staff establishes. Late entry applications will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the PNGA in order to submit a late entry application.

CONDITIONS

The PNGA Champion of Champions Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and may be subject to disqualification under the PNGA Code of Conduct at any time, from any PNGA Championship. **The PNGA Code of Conduct will be provided to all contestants prior to the Championship.**

CARTS

The use of automotive carts during the championship is permitted. Cart fees are \$99 per team, includes three rounds, and must be paid during registration. Spectator carts will not be permitted.

CADDIES

A player may provide his own caddie. Host club caddies will not be available.

DRESS CODE

The PNGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. The full PNGA Dress Code Policy can be found online at www.thepnga.org/policies and will be provided to all players, along with any additional measures required by the host club, after the entry deadline. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

PRACTICE ROUND

All contestants will be allowed one complimentary practice round prior to the championship on either course. Practice rounds on the secondary course can be scheduled for a special reduced rate of \$30 + tax. Consideration will be made for out-of-town players with regard to reserved starting times the day prior to the championship. Contestants can reserve practice round times directly through the golf shop. All practice round times are at the discretion of the golf shop staff.

CHAMPIONSHIP SCHEDULE

54-hole Team Stroke Play Competition (gross and net) with each Championship playing from a separate set of tees. Teams will be flighted based on course handicap. Play will be contested over two different courses, using a different team format each day. In the event of a tie for the gross championship, the winners will be decided immediately by a hole-by-hole playoff. All other ties will be broken using USGA retrogression.

WITHDRAWAL POLICY

All refunds prior to the entry deadline are subject to a \$10 administrative fee. Refunds are not available after the closing deadline except for documented and approved medical reasons. Refunds approved after the closing deadline, and up until round one pairings are released, are subject to a \$25 administrative fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

During play of the championship, a competitor must notify PNGA staff and state her need to withdraw. Entrants who unofficially withdraw (by not notifying the PNGA staff or without having sufficient reason to withdraw) will not be granted entry into any future PNGA championship for a minimum of two years.

LODGING

The PNGA recommends that contestants make their lodging arrangements at the earliest possible date. The PNGA provides highly discounted rates on hotels. Contestants can access hotel deals on the PNGA Women's Senior and Super Senior Team Championship web page (www.thepnga.org).

CHAMPIONSHIP EXEMPTIONS

A place in the field will be reserved for the **2018 PNGA Women's Senior Team Champions, Ginny Burkey and Leilani Norman; 2018 PNGA Women's Super Senior Team Champions, Mary Ryan and Sun Douthit; and the PNGA Women's Senior and Super Senior Team Champions from 2014-2017.** Note: The teams must be made up of the same players in order to receive exemption (*Exempt players must meet the eligibility requirements*).
